- Beginning with the Base Salary of \$52,350 from the 2022 Compensation & Benefits Manual.
- Add in \$6,500 (\$500 per year since ordination * 13-years) = \$58,850.
- Multiple this amount by 120% (a 20% premium afforded to the bishop) = \$70,620.
- Add in compensation for additional degrees, certification, years of other relevant professional experience.
 - Adding in 3-years of service as an Assistant to the Presiding Bishop ELCA (3 years * \$500 per year = \$1,500).
 - Adding in 6-years of service as Assistant to the Bishop Allegheny Synod (6 years * 50% * \$500 per year = \$1,500).
- Starting first year salary: \$70,620 + \$1,500 + \$1,500 = **\$73,620**.
